

Just a brief update on the cabling of the tree drops earlier this year. The warm weather has pushed the time table forward and with big efforts from our members Dave Lawson, Denis Persells, Wes Miller, new member Steve Soegaard and myself the cabling process was completed in early March.

We have consulted with the DNR Fish Biologist to determine potential areas for placing our brush bundles. Water depth is the main concern to ensure that any structures (bundles, etc.) are in enough water to have at least 5 or 6 feet over the top.

We are ready to go but materials are needed to move forward with the plan. If you have any cinder blocks laying around and would like to donate them for brush bundles, please contact me and I will pick them up.

Keep in mind that this project is designed to improve our lake for everyone, and we all benefit from it, not just the fisherman. Any donations would be greatly appreciated!

## Clean Boats, Clean Waters Update: Landing Monitor and Volunteers

A CBCW (Clean Boats, Clean Waters) grant was secured again from the DNR to pay for most of the expense of staffing a monitor at the Windigo Lake boat landing on Highline Road for 2017. Dennis Dollhopf will be returning for the third summer and will primarily be working weekends and holidays from Fishing Opener through Labor Day. #### Zebra Mussels Reported in NW Wisconsin

Late in 2016, zebra mussels were reported for the first time in the 12-county area making up NW Wisconsin. A property owner on Big McKenzie Lake in Washburn and Burnett Counties discovered the mussels attached to his pier while removing it from the lake for the season. His finding was confirmed by the DNR. The mussels resemble small clams with a yellowish or brownish D-shaped shell and alternating dark- and light-colored stripes. Most are under an inch in size and they frequently grow in clusters attached to pier posts, boat lifts, rocks and other hard surfaces. The DNR has committed a \$20,000 early detection and response grant to the McKenzie Lakes Association to help respond to this AIS threat.

People who find zebra mussels or other invasive species should:

- Note the exact location where the organism was found;
- Take a digital photo in the setting where the species was found, then collect up to five specimens of various sizes and put in a jar with water; put the jar on ice and refrigerate it; and
- Deliver the specimens to Pat Brown, our local AIS expert, at his office at the Sawyer County Courthouse. You can also contact Colleen Graham to do the reporting.




#### Look for Curly Leaf Pondweed from Ice-Out through June

As soon as ice is off our lakes, it's time to look for Curly Leaf Pondweed (CLP), an underwater plant that usually grows in lake water 3 to 10 feet deep. CLP grows well in cold temperatures, even under the ice. Since it's

already growing at ice-out, it can shade out smaller native plants and form dense mats that make it tough to boat or swim. When curly-leaf pondweed dies back in mid-summer, it releases nutrients that can fuel algae blooms and cause other problems. It is easily spread by boats and trailers.

Thanks to everyone who is monitoring and looking for AIS.

#### Remember to get your free annual burning permit from the DNR

As a reminder, <u>burning permits are required by law</u> in our area by the Wisconsin DNR to conduct legal and responsible burning in the outdoors. Annual burning permits are free and easy to obtain. They encourage the public to burn safely and are proven to be effective in protecting lives, property and natural resources from the damages of wildfires.

On the day you wish to burn after 11 a.m., check the daily burning restrictions on the DNR website or call the hotline 1-888-WIS-BURN (947-2876) and select the county where you plan to burn (Sawyer County is 58). Fire conditions change quickly, so it's important to check each day you burn to find out if burning is allowed, burning hours and any size limitations.

Also, note that if you are burning leaves, it is important to burn safely well away from the water's edge. Burning leaves too close to water can cause damage to aquatic systems. Burning leaves produces ash, phosphorus and carbon residues. As these residues are washed into the lake, it can cause temporary anoxic conditions harmful to fish and aquatic insects.

#### **Springtime Friendly Boating Reminders!**

Each spring, we like to remind everyone about boating considerations and safety. With water levels returning to higher levels in the past year or so, there is more shoreline erosion happening and we continue to hope that we can have nesting loons and surviving chicks. It continues to be concerning to many property owners that young loons seem unable to survive on Windigo.

Also, as a particular reminder for the benefit of the loons, NON-motorized boats getting too close to nesting areas are a serious threat to loon health because adult loons become stressed and will readily abandon a nest when strangers approach. So, please stay well clear of the loons. It is suspected that close approaching kayakers may have had a detrimental impact on nesting loons in one of the bays last year.

Please be kind to your neighbors and the health of our lakes by boating at no-wake speeds in Portage Bay and other bays of Windigo and observing DNR regulations in general. If you have guests, please just make sure they know about our no-wake zones, our loons, and considerate boating practices.

The DNR regulations for ANY Wisconsin lake are that boats need to have no wake 100 feet from shore and for personal watercraft (PWC), the no-wake law specifies that they need to be 200 feet from shore before a wake is

allowed. PWC also need to slow to no-wake speeds when they are within 100 feet of another boat.

These regulations are set to enable everyone's enjoyment of the lakes and also help us preserve the natural shoreline that all of us appreciate as compared to many other lakes in the Hayward area. We are lucky that Windigo is large enough that there is plenty of room out in the middle of the two large bays of the lake for higher speed boating activities. #### **Treasurer's Report**

Thanks to everyone who supports our lake association. Membership renewals are coming in. A complete report on 2017 Membership Dues paid, as well as the voluntary donations, will be provided in our next Newsletter.

Here is an update on our DNR Clean Boats Clean Water Grants which fund the monitoring of our boat landing. These grants are 75% funded by the Wisconsin DNR with a 25% match provided by WLPOA. Our match can be satisfied with cash or by supplying "in-kind" donations of labor. These donations must be related to boat landing monitoring and can't include time donated toward AIS monitoring or other activities beneficial to Windigo.

We spent \$ 2,835 during the summer of 2016 on monitoring of the boat landing. We received a reimbursement check for the full amount last December since we had provided sufficient volunteer hours. Thus our 2016 grant account has been closed out with a zero balance as shown below.

WLPOA has been awarded another DNR Clean Boats Clean Water Grant for 2017 and we have received an advance of \$ 750. This account balance is also shown in the table below.
