## **Legislative Action on Shoreline Zoning**

There was a flurry of activity at the state level in the last session after changes introduced in the budget last summer limited local control of shoreline zoning and regulation. The Lake Policy Report published by the Wisconsin Lakes organization summarizes the current state of major bills and amendments. ## Clean Boats, Clean Waters Update: Now Hiring Boat Landing Monitors!

In accordance with the Clean Boats, Clean Waters grant awarded to WLPOA for 2016, we are seeking one or more people to work at the Windigo boat landing on weekends and holidays checking boats and trailers for invasive species.

#### Responsibilities include:

- Tracking (primarily) day-use traffic at the landing;
- Asking a defined set of questions provided by the DNR and recording the answers;
- · Visually inspecting boats and trailers for vegetation;
- · Distributing educational materials.
- Qualifications of the ideal candidate include:
- Knowledge of and/or interest in aquatic invasive species;
- Confidence and maturity;
- Reliable transportation
- Willingness to work split shifts on weekends and holidays;
- Ready access to the internet with an email account preferred but not required.

The position will commence at ice-out or fishing opener, whichever is later, and continue through Labor Day weekend. Pay is \$10/hour or commensurate with experience. If you know anyone who is interested in this job

## Yes, we are excited to be back on the water soon! Friendly Boating Reminders! Barb Pievach

Each spring, we like to remind us all about boating considerations and safety. Last year, there were a couple of particularly busy boating weekends when higher speed boats were near Loon 'hangouts' on the west side Windigo and we also learned from some research up at Northland College that boats are the most prevalent cause

of loon deaths. We cannot conclude absolutely that increased speed boating near loons is the reason that we have not had a baby loon survive on Windigo for many years, but it is a possible reason. Also, as a reminder for the benefit of the loons, NON-motorized boats can also be a threat to loon health if the adult loons become stressed. So, please use those telephoto lenses and stay well clear of the loons if possible.

Also, please be kind to your neighbors and the health of our lakes by boating at no-wake speeds in Portage Bay and observing DNR regulations when boating throughout Windigo!

If you have guests, they may not know about our efforts to preserve the beauty of our lakes and our wildlife, and so many lakes do not work as hard as we do to keep our lake AIS free, healthy and beautiful. So, please just make sure your guests who may be boating know about our no-wake zones, our loons, and considerate boating practices.

The DNR regulations for ANY Wisconsin lake are that boats need to have no wake 100 feet from shore and for personal watercraft (PWC), the no-wake law specifies that they need to be 200 feet from shore before a wake is

allowed. PWC also need to slow to no-wake when within 100 feet of another boat.

These regulations are set to enable everyone's enjoyment of the lakes and also help us preserve the natural shoreline that all of us appreciate as compared to many other lakes in the Hayward area. We are lucky that Windigo is large enough that there is plenty of room out in the middle of the two large bays of the lake for higher speed boating activities.

Thank you to everyone who supported our lake association last year. We had 78 property owners pay dues representing Lake 27 and Windigo and Hub lakes.

Dues Reminders were sent out in February. Thanks to everyone who has already sent in your dues. Our membership form includes options for making voluntary donations to our Invasive Species Fund



and our Fishery Management Fund. Members are also asked to select their preferred method of Newsletter delivery – either email (November, March and June newsletters) or postal delivery (November and March Newsletters) or both.

Note that for our June Newsletter and for occasional quick communication on behalf of our association, we ARE requesting emails from everyone. Email is our preferred method of newsletter delivery,

WLPOA serves property owners on Windigo Lake, Hub Lake, and Lake 27 by promoting communication and cooperation among lakeshore owners and by working with the DNR and local government to maintain lake quality and protect our lake from invasive aquatic weeds. WLPOA, Inc. is a nonprofit 501(c) (3) organization so your membership donation is tax-deductible as provided by law.

### **Treasurer's Report**

A report on 2016 Membership Dues paid, as well as the voluntary donations, will be included in the next Newsletter. Here is an update on our DNR Clean Boats Clean Water Grants which fund monitoring of our boat landing. These grants are 75% funded by the Wisconsin DNR with a 25% match provided by WLPOA. Our match can be satisfied with cash or by supplying "in-kind" donations of labor. These donations must be related to

boat landing monitoring and can't include time donated toward AIS monitoring or other activities beneficial to Windigo.

During 2015 WLPOA spent \$ 3,090 on monitoring the boat landing. We had received an advance of \$ 750 and during last November we filed our paperwork for final reimbursement. A check for \$2206.50 was received bringing the total covered by the DNR to \$ 2956.50 This year our "in-kind" match fell a bit short so WLPOA will use a cash match of \$ 133.50 from our General Fund to bring this account to zero and close it out.



WLPOA has been awarded another DNR Clean Boats Clean Water Grant for 2016 and we have received an advance of \$ 750. This balance is shown in the table below.

# AIS Update: Look for Curly Leaf Pondweed from Ice-Out through June Barb Pjevach

As soon as ice is off our lakes, it's time to look for Curly Leaf Pondweed (CLP), an underwater plant that usually grows in lake water 3 to 10 feet deep. CLP grows well in cold temperatures, even under the ice. Since it's already growing at ice-out, it can shade out smaller native plants and form dense mats that make it tough to boat or swim. When curly-leaf pondweed dies back in mid-summer, it releases nutrients that can fuel algae blooms and cause other problems. It is easily spread by boats and trailers.

Thanks to those of you who have volunteered to be shoreline monitors, but also remember that anyone can search for AIS.

More detailed pictures and instructions for how to look for Curly Leaf Pondweed and other Aquatic Invasive Species are on the <u>AIS page on our website</u>. Thanks for your continued vigilance in keeping our lakes AIS-free!

As a reminder, the time to find Eurasian Milfoil, the other AIS in our area, starts in June.
